**RETAINED AS INDEPENDENT REGISTERED**  
**MUNICIPAL ADVISOR**

**By publicly posting the following written disclosure, the Authority intends that market participants receive and use it for purposes of the independent registered municipal advisor exemption to the SEC Municipal Advisor Rule.**

The Puerto Rico Fiscal Agency and Financial Advisory Authority (the “Authority”) has retained an independent registered municipal advisor (the “IRMA”) for matters related to the Commonwealth of Puerto Rico, and the instrumentalities and public corporations listed in Appendix A. The Authority is represented by and will rely on its IRMA, Public Financial Management, Inc. (“PFM”), to provide advice on capital financing transactions, which includes ongoing financial advice, transaction management, pricing, execution, and advisory activity; and for the analyses and evaluations of available transactions, strategies, and policies. This certificate may be relied upon until June 30, 2017.

The term IRMA shall include all meanings attached to any of the terms: municipal advisory, financial advisory, and municipal financial advisory, as they are used by the United States Securities and Exchange Commission and the Municipal Securities Rulemaking Board; or the subject of the Dodd-Frank Act.
